Fee :	Rs. 40,500/- + 6,075/- (S.T. @ 15%*) = Rs. 46,575/-
Ist Installment (At the time of admission) :	Rs. 25,000/- + 3,750/- (ST @ 15%) = Rs. 28,750/-
IInd Installment (within 60 days of Admission) :	Rs. 15,500/- + 2325/- (S.T. @ 15%) = Rs. 17,825/-

Fee structure for integrated IX & X Pre foundation course :

Fee :	Rs. 75,500/- + 11,325/- (S.T. @ 15%) = Rs. 86,825/-

SCHOLARSHIP

Fee Payment Options

- At our Head Office Durgakund (Varanasi)**
Take fee slip/challan from fee counter and deposit the cash in **Canara Bank**, Lanka (Near Sankat Mochan Crossing), branch. **Cheque/D.D.** in favour of "JRS Tutorials" can be deposited at fee counter itself.
